### How to Qualify for Health & Vision Benefits

You must be currently working as an IHSS Provider and have 25 authorized paid/worked IHSS hours **each month** for the last **two consecutive months**.

### How to Qualify for Dental Benefits

You must be currently working as an IHSS Provider and have 25 authorized paid/worked IHSS hours **each month** for the last **six consecutive months**.

## LIVESCAN FINGERPRINT SERVICES

### To Qualify for LiveScan Fingerprint

1. You must complete the IHSS orientation with IPAC (Independent Provider Assistance Center).
2. Obtain your assigned 9-digit IHSS ID number provided by IPAC.
3. Schedule your LiveScan appointment by scanning the QR code below or by visiting: [www.sfhsspa.org/livescan](http://www.sfhsspa.org/livescan)
4. Must bring your completed BCIA 8016 form (Request for LiveScan) and a valid government issued photo ID.
5. Visit our office for your LiveScan appointment.

#### THINGS TO REMEMBER

- LiveScan services are provided by appointment only. No walk-ins.

## PERSONAL PROTECTION EQUIPMENT (PPE) KITS

### To Receive a PPE Kit

1. Must be a current & active IHSS Provider.
2. Schedule your pick-up appointment by scanning the QR code below or by visiting: [www.sfhsspa.org/ppe](http://www.sfhsspa.org/ppe)
3. Present your IHSS ID Card or a valid government issued photo ID along with your most current paycheck.
4. Pick up your PPE Kit on the scheduled appointment date & time.

#### THINGS TO REMEMBER

- PPE distribution kit pick-up is allowed once a month, per provider.
- Appointments are on Mondays from 10am to 3pm.

## IHSS PROVIDER IP/ID CARD

### To Receive an IHSS Provider IP/ID Card

1. Must be a current & active IHSS Provider.
2. Completed orientation and LiveScan fingerprinting background check.
3. Schedule your pick-up appointment by scanning the QR code below or visiting online: [www.sfhsspa.org/ip-id-card](http://www.sfhsspa.org/ip-id-card)
4. You must bring a valid government issued ID along with the most current paycheck at your appointment.

#### THINGS TO REMEMBER

- Possession of an IHSS IP/ID cards are optional, not mandatory.
- Scheduled appointment days are on Mondays from 10am to 12pm.
